Tenders are hereby invited for the **Supply, Installation and Commissioning of the 88kV Control & protection panels at LANG Substation** in the Steve Tshwete Municipal region. **Tenderers should have a CIDB contractor grading of 3EP or higher.** The contract comprises mainly of **the replacement of 88kV CONTROL & PROTECTION Panels.**

Only bank guaranteed cheques or cash will be accepted. Cheques shall be made payable to the Steve Tshwete Local Municipality.

Duly completed tender enclosed in a sealed envelope marked **"TENDER NO. BS-05/11/2012: LANG 88/11kV SUBSTATION: REPLACEMENT OF 88KV CONTROL & PROTECTION PANELS** with the name of the Tenderer, shall be deposited in the tender box provided at the Steve Tshwete Local Municipality on the 2nd floor, Civic Centre, Wanderers Avenue, Middelburg, before **12H00** on the closing date. The tenders will be opened in public.

A compulsory clarification meeting with representatives of the Employer will take place at the Municipal Library (Auditorium) at the corner of Walter Sisulu (Kerk Street) & Wanderers avenue, Middelburg on **WEDNESDAY, 12 DECEMBER 2012** starting at 10H00 hrs. Contract documentation will not be available on site, and the Engineer will not be available for inspection purposes on any other occasion.

Contractors who have the following are eligible to tender and must provide such proof:

- Original Valid Tax Clearance Certificate
- Company Registration Certificate
- Proof of CIDB Registration 3EP or higher
- Original Valid B-BBEE Status Level Verification Certificate. (0 Points if not submitted)

A preferential point system shall apply whereby a contract will be allocated to a tenderer in accordance with the Preferential Procurement Policy Framework Act, Act No 5 of 2000 and as defined in the Conditions of Tender in the tender document, read in conjunction with the Supply Chain Management Policy of Steve Tshwete Local Municipality where 90 points will be allocated in respect of price and 10 points in respect of B-BBEE. Tenderers must have the necessary skills, experience and capacity to perform the required work.

No awards will be made to a person:

- Who is in the service of the state,
- If that person is not a natural person, of which any director, manager, principal shareholder or stakeholder is a person in the service of the state
