Tenders are hereby invited for the electrification of Tokologo in the Steve Tshwete Municipal region. **Tenderers should have a CIDB contractor grading of 3EP or higher.** The contract comprises mainly of **LV reticulation and house connections.**

Cheques shall be made payable to the Steve Tshwete Local Municipality.

Duly completed tender enclosed in a sealed envelope marked "TENDER NO. **BS 06/08/2012: ELECTRIFICATION OF 120 STANDS IN TOKOLOGO**" with the name of the Tenderer, shall be deposited in the tender box provided at the Steve Tshwete Local Municipality on the 2nd floor, Room C301, Civic Centre, Wanderers Avenue, Middelburg, before 12H00 on the closing date. The tenders will be opened in public.

A compulsory clarification meeting with representatives of the Employer will take place at the **Electrical workshop, CNR Walter Sisulu and Protea Park, MIDDELBURG** on **Tuesday 28 August 2012** starting at **10H00** hrs. Contract documentation will not be available on site, and the Engineer will not be available for inspection purposes on any other occasion.

*Bidders will be evaluated on functionality whereby 60 points has to be attained before financial proposals can be looked at. Points will be allocated as follows: Bidders experience- 30 points, Construction resources – 20 points, experience of key staff – 30 points and Financial means-20 points. A preferential point system shall apply whereby a contract will be allocated to a tenderer in accordance with the Preferential Procurement Policy Framework Act, Act No 5 of 2000 and as defined in the Conditions of Tender in the tender document, read in conjunction with the Supply Chain Management Policy of Steve Tshwete Local Municipality where **90** points will be allocated in respect of price and **10** points in respect of B-BBEE Status level of contribution. Tenderers must have the necessary skills, experience and capacity to perform the required work.*

No awards will be made to a person:

- Who is in the service of the state,
- If that person is not a natural person, of which any director, manager, principal shareholder or stakeholder is a person in the service of the state.

- Original Valid Tax Clearance Certificate
- CIDB certificate grading of 3 EP
- Certified valid B-BBEE certificate (non-compulsory, failure to submit no points will be awarded).
