The tenders will be opened in public.

A **compulsory** clarification meeting with representatives of the Employer will take place at the Steve Tshwete Local Municipality on the 1st floor, Civic Centre, Room D212, Wanderers Avenue, Middelburg on 21 August **2012** starting at 10:00 hrs. Contract documentation will not be available at the clarification meeting.

*A preferential point system shall apply whereby a contract will be allocated to a tenderer as defined in the Conditions of Tender in the tender document, read in conjunction with the Supply Chain Management Policy of Steve Tshwete Local Municipality where 80 points will be allocated in respect of price and 20 points in respect of B-BBEE Status Level of Contribution. Tenderers must have the necessary skills, experience and capacity to perform the required work. Only those tenderers/bidders/company's who score a minimum score of **60 points** in respect of the functionality criteria will proceed to the price and preference goals evaluation stage.*

- Company registration Documents
- Original valid Tax Clearance certificate
- Certified copy of BBBEE status Certificate (Not compulsory but failure to submit certified copy no points will be awarded for BBBEE status)

No awards will be made to a person:
