Cheques shall be made payable to the Steve Tshwete Local Municipality.

Duly completed tender enclosed in a sealed envelope marked "**TENDER NO. BS 12/10/2012 4 X 30 METER HIGH MAST LIGHTS IN BLINKPAN,SOMAPHEPHA AND ROCKDALE MIDDELBURG**" with the name of the Tenderer, shall be deposited in the tender box provided at the Steve Tshwete Local Municipality on the 2nd floor, Civic Centre, Wanderers Avenue, Middelburg, before 12:00 on the closing date. The tenders will be opened in public.

A compulsory clarification meeting with representatives of the Employer will take place at the Gerald Sekoto Library Auditorium at the corner of Walter Sisulu & Wanderers avenue Middelburg on Wednesday 24 October 2012 starting at 11:00 hrs. Contract documentation will not be available on site.

Bids will be pre-qualified in accordance with functionality criteria as outlined in the tender. Only the bids that meet the minimum number of 70 points out of 100 points for functionality will proceed to the price and preference goals evaluation stage.

A preferential point system shall apply whereby a contract will be allocated to a tenderer in accordance with the Preferential Procurement Policy Framework Act, Act No 5 of 2000 and as defined in the Conditions of Tender in the tender document, read in conjunction with the Supply Chain Management Policy of Steve Tshwete Local Municipality where 80 points will be allocated in respect of price and 20 points in respect of B-BBEE Status Level of Contribution. Tenderers must have the necessary skills, experience and capacity to perform the required work.

No awards will be made to a person:

- Who is in the service of the state,
- If that person is not a natural person, of which any director, manager, principal shareholder or stakeholder is a person in the service of the state

Contractors who have the following are eligible to tender and must provide such proof:

- Original valid tax clearance certificate
- Company registration certificate
- CIDB grading of 2 EP
- Certified copy of BBBEE certificate (non compulsory, failure to submit no points will be awarded)
