A compulsory clarification meeting with representatives of the Employer will take place at the main building, room D212 (Technical & Facilities Board Room) on 13/11/2012 starting at 10:00 hrs.

The closing time for receipt of tenders is **12:00 hrs on 22/11/2012**. Telegraphic, telephonic, telex, facsimile, e-mail and late tenders will not be accepted.

Duly completed tender enclosed in a sealed envelope marked **"TENDER NO. BS 23/10/2012: supply, delivery and off-loading of 925 kg liquid chlorine cylinders as and when required by Steve Tshwete local municipality for a period of twelve (12) Months"** with the name of the Tenderer, shall be deposited in the tender box provided at the Steve Tshwete Local Municipality on the 2nd floor, Civic Centre, Wanderers Avenue, Middelburg, before **12h00** on the closing date. The tenders will be opened in public.

A preferential point system shall apply whereby a contract will be allocated to a tenderer in accordance with the Preferential Procurement Policy Framework Act, Act No 5 of 2000 and as defined in the Conditions of Tender in the tender document, read in conjunction with the Supply Chain Management Policy of Steve Tshwete Local Municipality where 80 points will be allocated in respect of price and 20 points in respect of B-BBEE Status Level of Contribution. Tenderers must have the necessary skills, experience and capacity to perform the required work.

Original valid Tax Clearance Certificate

Valid company registration certificate

Valid certified copy of B-BBEE Certificate. (non compulsory, but failure to submit , 0 points will be awarded for B-BBEE status)

No awards will be made to a person:

- Who is in the service of the state,

- If that person is not a natural person , of which any director, manager, principal shareholder or stakeholder is a person in the service of the state

- Who is an advisor or consultant contracted with the municipality or municipal entity
