A preferential point system shall apply whereby a contract will be allocated to a tenderer in accordance with the Preferential Procurement Policy Framework Act, Act No 5 of 2000 and as defined in the Conditions of Tender in the tender document, read in conjunction with the Supply Chain Management Policy of Steve Tshwete Local Municipality where 80points will be allocated in respect of price and 20points in respect of B-BBEE Status Level of Contribution. Tenderers must have the necessary skills, experience and capacity to perform the required work.

- 1. Company registration original or certified copy.*
- 2. Valid Tax clearance certificate.*
- 3. Original or certified copy of B-BBEE certificate.(Failure to submit will result in no point allocation.)*

No awards will be made to a person:

- Who is an advisor or consultant contracted with the municipality or municipal entity
